**SUBJECT: 2026 BOYS VOLLEYBALL DISTRICT TOURNAMENT**

**To count in the power rankings, all matches must be completed by Monday, May 11.**

**If a team chooses not to participate, the principal must send a letter to Frank Majikes by Friday, May 8.**

**AAA:** All teams qualify and will be seeded using the power ranking. Tournaments that utilize modified scoring will not count in either the power rankings or winning percentage. The quarterfinals will be held at the highest seed in single match format. There is no admission charge for the first round. No line judges will be assigned for the quarterfinal round. Semi-final round will be held at the highest remaining seed in a double header. There will be an admission charge and tickets will be available through HomeTown Tickets. The home team will be responsible for the fees for the trainer and security. The District II

Committee will be responsible for the payment of officials, 3 table workers and 1 ticket scanner. The visitors will be responsible for their transportation. Finals will be at a neutral site. Admission will be charged. The District II Committee will cover all costs.

Dates: Quarterfinals—Wednesday, May 13

Semi-finals—Tuesday, May 19

Finals—Thursday, May 21

**AA:** The top 8 teams will qualify plus any other team that has a .500 winning percentage in either the league or overall record. A minimum of 8 teams will qualify but there is the potential for more teams to qualify. Play-in games (if needed) and quarterfinal will be held at the higher seed. These will be single game format. No line judges will be assigned. The host school will cover all costs. The semi-final round will be a double header held at the highest remaining seed. The host school will provide and cover the cost of a trainer and security. The visitors will pay for their own transportation. The District II Committee will pay for the officials, 3 table workers and 1 scanner. The finals will be held at a neutral site. All fees will be paid by District II.

Dates: Play-in (if necessary)—Tuesday, May 12

Quarterfinals—Thursday, May 14

Semi-finals—Tuesday, May 19

Finals -Thursday, May 21

All matches will be best of 5 rally scoring. The first 4 sets will be 25 point sets with no caps. The 5<sup>th</sup> set, if necessary, will be a 15 point set with no caps.

State Tournament dates— District II will qualify 2 teams in AA and only the District Champion in AAA.

First round: Tuesday, June 2  
Quarterfinals: Saturday, June 6  
Semi-finals: Tuesday, June 9  
Finals: Saturday, June 13 -Penn State Rec Hall

All matches will be the best of 5 rally scoring. The first four sets will be 25 point games with no caps. If the fifth set is necessary it will be a 15 point game with no cap. A team must win a set by 2 points.

More information will follow as the season concludes. Please keep your team's results updated on the power rankings page so that proper seeding can take place. Each team that qualifies will be notified through their athletic director as soon as the final matches and final seedings are completed. The LIAA contact person is Nick Swaha at North Pocono High School. The WVC contact person is J. P. Aquilina at Holy Redeemer High School.

A complete packet of further necessary information will be e-mailed to those schools that are in contention for a playoff spot. That information will be sent out to those schools in early May.
